## Lori Sturdevant on April 5: Lessons for the next women's movement

Lori Sturdevant writes editorials and a weekly column about topics that she covered for more than 35 years—state government and politics. She joined the *Minneapolis Tribune* as a summer replacement reporter in 1975, returned as a reporter in 1976, and was lead capitol reporter and newsroom assignment editor before joining the Tribune's editorial staff in 1992.



A native of South Dakota, Lori is a graduate of Coe College in Cedar Rapids, Iowa, and a member of that institution's Board of Trustees. She has been the author, editor, or co-author of 10 books. Her subjects have included Rosalie Wahl, Minnesota Supreme Court justice; Governor Elmer L. Andersen; and the Pillsbury family. Her most recent book is *Citizen Swain*, which she co-authored with Tom Swain.

Lori is a three-time winner of the Minnesota Book Award. She lives in St. Paul with her husband; they have three grown children.

## Remembering Flossie, past president and friend

Florence A. Caldwell died on December 31, the last day of 2015. Known to her friends as Flossie, she was loved by all who knew her for her ready smile and modesty about her many talents and accomplishments. She played tennis, played in a string quartet, and loved expressing her love of nature in photography and watercolor painting. She fit right into Minnesota life, enjoying annual canoe camping trips with her husband, Elwood, and frequently hiking the north shore Superior Hiking Trail with friends.

To her many UMWC friends, she will be forever remembered as the woman who made them feel welcomed to the club. Members, who hark back to the days when UMWC was the Faculty Wives Club, recall that Flossie never missed a chance to recruit. Flossie would spring into action on campus elevators and department gatherings, asking wives if they belonged to the club and handing them a brochure. She brought in many members herself and was a one-woman welcoming committee for all.

By 1988 she had already instilled her love of hiking in a new section for the club, and 16 years later, she was still getting out with the Hikers. She also started Around the Campus and Vagabonds and was active in the Art, Music, and International Sections.

A comment expressed by many: It is hard to think of anyone who has done more for the U of M Women's Club.

In 1990 Flossie was asked to take the reins as president. Her first reaction? "I'm 70; I'm too old; what can I do?" After the third ask, she took the job and proceeded to "dig in full force." A born planner and dynamic organizer, she took the club "where it had never gone before." During her two-year presidency, she continued to expand the membership, promoted a name change, and opened membership to all community women. It is fair to say that this significant change is responsible for the continued vitality of the University of Minnesota Women's Club today.

In her own words, Flossie wanted to be "Remembered by the friends I have made and by my love of nature." Her wish is surely granted. True to the way she conducted her life, Flossie planned her own memorial service, including asking that all memorial gifts be donated to the UMWC Scholarship Fund. Flossie will live on in the hearts of all who knew her and in the good works of the UMWC.

We are her legacy.
