Co-Treasurers Report – Sandy Gale (Sue Madison was not in attendance)

- Tax update the information to file our 990 tax form has been sent to our tax preparer.
- A co-treasurer has been added and this is our first year of splitting the duties. Sue Madison will be
 receiving scholarship contributions (from individuals and from financial institutions), depositing the
 checks and handling the accounting.
- The 37-page Treasurer Procedures Manual was completed in July. It will not be posted online due to confidential data.
- Banking is done through TCF, now Huntington Bank. The current business account does not
 accommodate access for two users to view information online. We will receive information from
 Huntington Bank as to how accounts may change. We may have an account with a fee.
- Send information to both Sandy and Sue to keep them informed.

Auditor's Report - Susan Hopp for Peggy Tang

- I completed an audit of the University of Minnesota Women's Club financial statements and accounting records prepared by Sandy Gale, UMWC Treasurer. The scope of my review included the Operations account and the Scholarship Fund account for fiscal year July 1, 2020, through June 30, 2021.
- The audit was conducted according to generally accepted auditing standards and accounting principles. They guide the audit to determine a reasonable assurance about whether financial reports are free of any material misstatement and accounting records are complete and accurate. The audit includes examining evidence supporting the amounts in financial statements.
- It is my opinion the financial reports and records are an accurate picture of the financial position of the University of Minnesota Women's Club.
- Included in the audit is the Auditor Notes associated with the audit.

Conversations – Barbara Swadburg (Maggie Hoover not in attendance)

- Since meeting in May, the Conversations Committee has secured speakers for the Conversation
 Luncheons, as listed in the directory. Ingrid Lund has also recruited Janee Harteau, former Chief of
 Police in Minneapolis, to speak at a special Zoom Meeting in March 2022.
- We look forward to presenting our Luncheon speakers in person this year.

Historian - Bonnie Marten for Liz Grimmer

The UMWC office in McNamara will be ready for move in at the end of September. Once it is ready, Bonnie and Liz will meet for an orientation and to unpack boxes.

Membership Chair – Georgia Heisserer

- The Membership Committee consisting of Shirley Hermann, Rolaine Wright, Diane Schweitzer,
 Carole Senty and myself have met and reviewed our goals during the summer. This is an important time of year for us.
- Carole Senty and President Susan Hopp have continued the transition of printing, as Dorothy and
 Fred Waltz have refined their focus. We have also redesigned messaging to our new members
 through name tags and new member information. Club stationery, business cards, tents for
 luncheon events, invitations, welcome letters, and reminder letters for late dues are also in

- transition. This process is ongoing and by no means complete at this time. The technical aspects continue to be refined.
- Membership Committee protocol will continue to contact new members and see that each person is
 clear about the opportunities afforded them. Our committee has spent a lot of time being sure all
 members feel ready to immerse themselves in our planned events. The committee realizes that the
 bulk of the welcome comes from in person experience, but our committee will follow up with
 welcoming visual messaging.

Scholarship Chair – Georgia Nygaard

- The UMWC Scholarship Committee had a very busy and very successful year. It was interesting to note the increase in the ethnic diversity and the diversity of the academic majors. For several years Nursing and Education majors were prevalent; today, we see Engineering, Law and Biology with Biology being a pathway to Medicine. These are currently the primary areas of interest.
- We received 137 scholarship applications and were fortunate to provide 59 scholarships to the
 University of Minnesota undergraduate students. Of the 59 scholarships, fifty students were
 awarded full \$3500 scholarships and 9 were partial scholarships ranging from \$1300 to \$3400. The
 total scholarship expenditure was \$192,150. Included in this amount were 21 One-year Named
 Scholarships and monies from the 6 endowed scholarships that are managed by the University of
 Minnesota Foundation.
- As a committee we appreciate the generous contributions by our UMWC members and friends. In addition, we are grateful for the genuine supportive assistance given to us by the University of Minnesota Office of Student Finance and the University of Minnesota Foundation. Thank you.
- 18 scholarship winners plan to attend the Scholarship Luncheon and 7 students need transportation to the event.

UMWC COVID-19 POLICY

Returning safely

As we resume in-person gatherings for 2021–2022, the health and safety of our members and guests continues to be our top priority. We are guided by optimism, caution and responsibility. The policies

outlined below are subject to change based on evolving city, state and CDC guidelines and will remain in effect until further notice. We will review regularly and change if necessary.

We will keep the membership up to date via emails and website updates so you know what to expect. Thank you for helping us keep our community as safe as possible.

Vaccination, mask and conduct policies

The CDC guidelines currently (September 20, 2021) states that fully vaccinated people can participate in many of the activities that they did before the pandemic; for some of these activities, they may choose to wear a mask.

Vaccination: Full vaccination is REQUIRED in order to attend any UMWC events, indoors and outdoors.

Interest Sections will also follow this requirement and, depending on the venue and its policy, may need to require proof of vaccination.

We respect your personal decision if you choose not to attend our functions, as we each have a different level of safety comfort depending upon our own health and circumstances. We will miss you but support you in your choices.

Mask: All members and guests are REQUIRED to wear a mask that securely covers the nose and mouth while entering buildings, regardless of vaccination status. Masks are strongly suggested indoors except while eating, drinking or speaking. It is your personal choice, but please be aware of others around you who may be affected by your choices. If you need a mask, just ask.

Foot traffic: Please stay in the areas we have designated for our events.

Feeling ill: Stay home and self-isolate when you feel ill. Be mindful of how you feel, and don't risk exposing others.

Hand sanitizer: Will be available.

Physical distance: Please be respectful and graciously maintain social distance. It is not possible for us to always create/guarantee a minimum of six feet between you and the person next to you.

Venues: Note that we do not have complete control over our venues, but will work with each to ensure that their safety policies are as strictly enforced as possible. We ask that all staff persons assisting us are required to wear masks, regardless of vaccination status. The management will contact us if anything changes on their safety protocol.
