MEMBERS OF THE ART SECTION ARE INVITED to show 1-3, two- or three-dimensional original drawings, paintings, hand-pulled prints, glass/ceramic pieces, fabric art, or photographs. These works may be shown only once at an UMWC Art Exhibit. All work must be original to the artist. Works produced through kits or molds, as well as copies of other artists' work, will be disqualified.

General requirements are:

1. Paid \$50 UMWC annual dues, check made out to UMWC and sent to Nancy Myers, UMWC, 1578 Burton Street, Falcon Heights, MN 55108, Paid \$5 Art Section annual dues to Roz Anderson, 7911 Ithaca Lane N., Maple Grove, Mn 55311.
2. Submit a completed Intent to Exhibit form (included) by March 22, 2024 to Carol Lowe, 6938 – 3rd Ave S, Richfield, MN 55423 or lowejc@usfamily.net.

Not yet an Art Section member? You may qualify to submit work after paying the \$5 Section dues.

TWO-DIMENSIONAL PIECES must be properly matted, in wood or metal frames (no plastic) and under glass or plexiglass. Works on gallery-wrapped canvas are an exception: If they have clean, finished edges and no exposed staples they do not require framing. All works must be prepared for hanging (no saw-tooth fixtures, please). We reserve the right to reject improperly fixed pieces.

ARTISTS are asked to attend the Opening Reception on Tuesday, April 16, 2024, 3:00 pm and make an artist statement (who you are, description of your work, materials, subject matter, etc. and your motivation to do the work). Be succinct, colorful, and compelling! If you are unable to attend, please prepare a written statement and give it to Jane LaFroth so it can be read during the tour.
